OBJECTIVE

The investment objective of the North Star Micro Cap Fund (the "Micro Cap Fund") is capital appreciation, and secondarily, to derive income from short term liquid securities. The Fund seeks to achieve its objective of capital appreciation by investing in micro-cap companies, defined as companies with market capitalizations under \$1 billion.

WHY INVEST?

We look for situations that may be undiscovered by most investors due to their lack of size, liquidity, research coverage or intrigue. We focus our research on companies that have the potential to generate a high level of free cash flow and that we believe have strong or improving balance sheets.

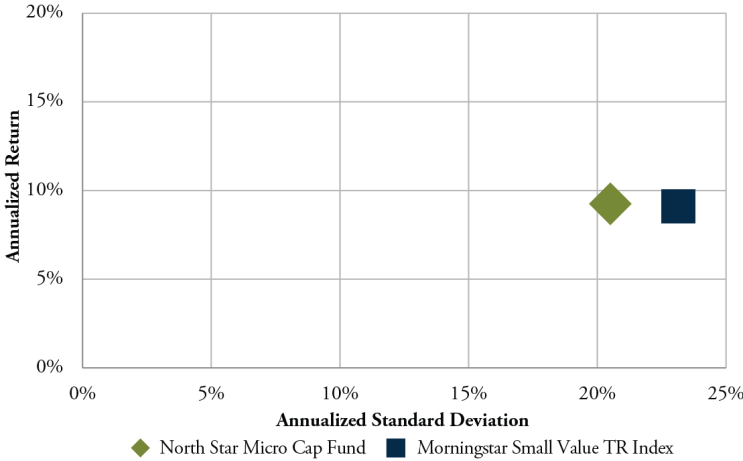

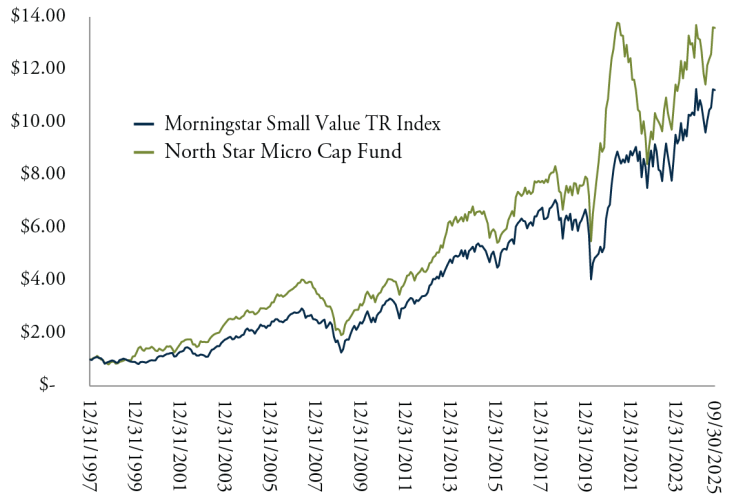
